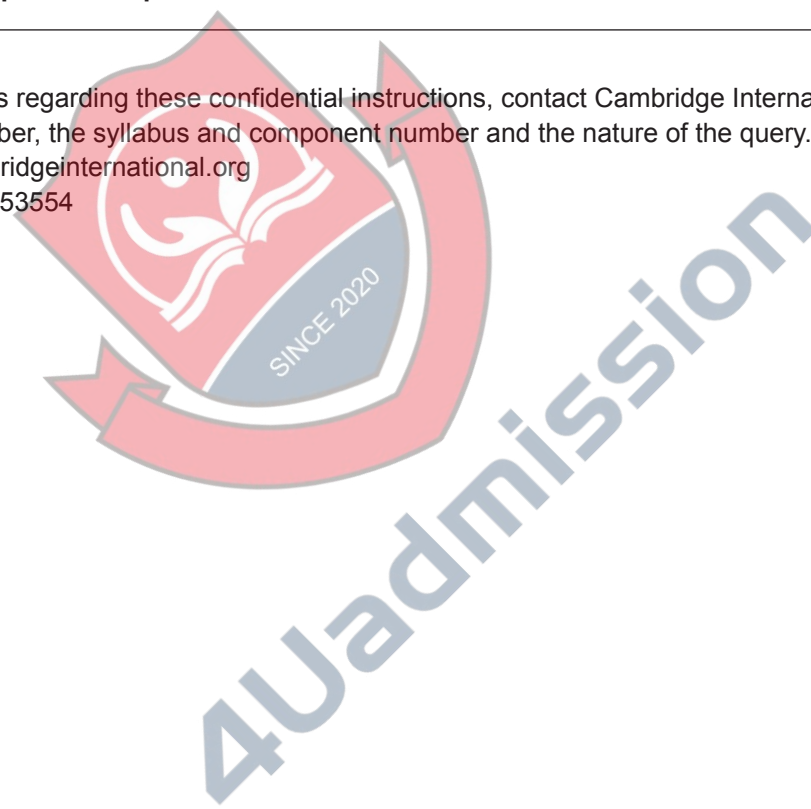

General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus **need to be replaced**, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

The supervisor must be a teacher of physics or other competent physicist who is familiar with the requirements of this syllabus. During the exam, the supervisor (**not** the invigilator) should obtain a sample set of numerical results by following the relevant steps in the question paper. The results should be clearly labelled 'supervisor's results' and recorded on the supervisor's report or on a spare copy of the question paper.

Organisation of the exam

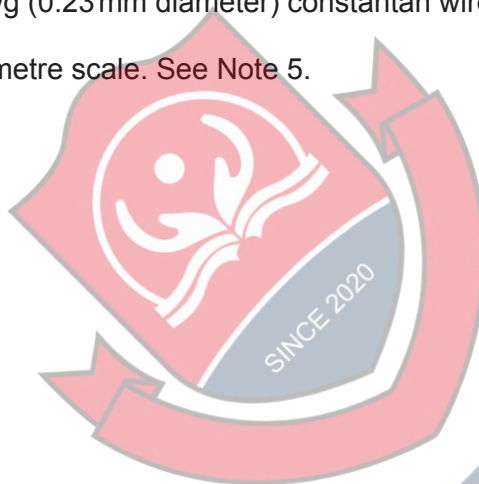
- The number of sets of apparatus provided for each experiment should be $\frac{1}{2}N$, where N is the number of candidates taking the exam.
- Candidates must **not** be provided with any additional apparatus beyond that specified in these instructions.
- Candidates should be allowed access to the apparatus for each experiment for one hour only.
- After spending one hour on one experiment, candidates should change over to the other experiment.
- The order in which a candidate attempts the two experiments is immaterial.

Assistance to candidates

- Candidates should be informed that, if they find themselves in real difficulty, they may ask the supervisor for practical assistance, but that the extent of this assistance will be reported to the examiner, who may not award full credit for the relevant skills.
- Assistance should only be given when it is asked for by a candidate or where apparatus is seen to have developed a fault.
- Assistance should be restricted to enabling candidates to make observations and measurements. Observations and measurements must **not** be made for candidates, and no help should be given with data analysis or evaluation.
- In cases of faulty apparatus that prevent the required measurements from being taken, the supervisor should allow extra time to give the candidate a fair opportunity to perform the experiment as if the fault had not been present.
- Any assistance or extra time given to candidates must be recorded in the supervisor's report.

Materials and apparatus for Question 1 (per set of apparatus unless otherwise specified)

- 1.5 V d.c. power supply (e.g. 1.5 V dry cell) with terminals.
- Digital ammeter set to the range 0–200 mA reading to the nearest 0.1 mA. If a digital multimeter is used, the range should be fixed and any unused terminals should be covered.
- Six $12\ \Omega$ resistors. See Note 1 and Note 2.
- Two component holders. See Note 2.
- Wooden block with approximate dimensions $10\text{ cm} \times 2\text{ cm} \times 1\text{ cm}$. See Note 2.
- Five nails each of approximate diameter 2 mm and approximate length 2 cm. See Note 2.
- Nine connecting leads.
- Five crocodile clips. See Note 3.
- 110 cm length of 34 swg (0.23 mm diameter) constantan wire. See Note 4 and Note 5.
- Metre rule with a millimetre scale. See Note 5.
- Switch.

Notes

- 1 The resistors should each have a maximum tolerance of 5% and a minimum power rating of 0.5 W (e.g. RS Components stock number 738-2595).
- 2 Five nails should be hammered into the wooden block as shown in Fig. 1.1.

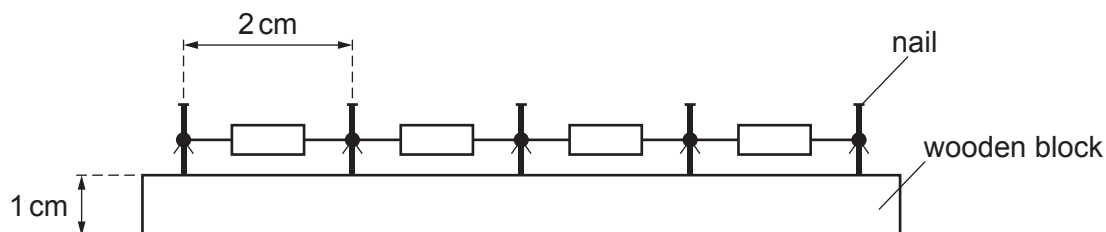

Four of the resistors should be soldered to the nails as shown in Fig. 1.1.

One of the remaining resistors should be placed in one of the component holders. This component holder should be labelled X.

The remaining resistor should be placed in the other component holder. This component holder should be labelled Z.

- 3 The jaws of the crocodile clips should be cleaned so that they make a good electrical contact with the resistance wire.
- 4 If this wire is not available, other resistance wire of approximate resistance $10\ \Omega\ \text{m}^{-1}$ may be used.
- 5 The wire should be securely attached to the metre rule using tape, as shown in Fig. 1.2.

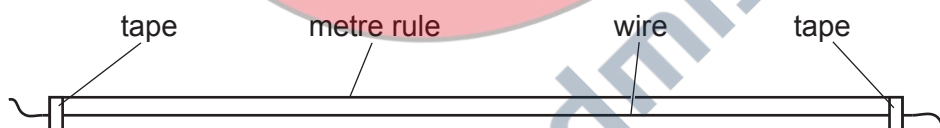

- 6 The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be dismantled and restored to its original state.

Materials and apparatus for Question 2 (per set of apparatus unless otherwise specified)

- Stand of height at least 60 cm.
- Boss.
- Clamp.
- Two 10 g slotted masses with their mass values clearly shown.
- Two 50 g slotted masses with their mass values clearly shown.
- Metal or wooden rod with approximate length 10 cm. See Note 1.
- Rubber band with approximate circumference 20 cm and approximate cross-section 1 mm × 3 mm.
- 20 cm length of 20 swg (0.91 mm diameter) copper wire.
- Stop-watch reading to 0.1 s or better.
- Metre rule with a millimetre scale.
- Triangular glass or wooden prism of minimum height 2 cm suitable for use as a pivot.
- 30 cm ruler with a millimetre scale.
- Access to a balance reading to at least 0.1 g (shared between no more than four candidates).
- Lump of adhesive putty (e.g. Blu-Tack) with approximate mass 3 g.
- Small tray for the adhesive putty.

Notes

- 1 It should be possible to slide all masses onto the rod.
- 2 The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be restored to its original state. New copper wire should be provided. All adhesive putty should be returned to the tray.
